

# Minutes of the meeting of Middleham Town Council held in the garden room Middleham Key Centre on Wednesday 31<sup>st</sup> January 2024 at 6.30pm

- **24.01. Public Representations/Open Forum** 15-minute session for the public to raise issues with the Council None.
- **24.02 Apologies** Apologies for absence received from Cllr Watson and Cllr Mashford and reasons given for absence **approved**.
- **24.03 Declarations of Interest** and any dispensation requests regarding items on the agenda, other than any previously disclosed None.
- **24.04 Minutes of the meeting held on Wednesday 13<sup>th</sup> December 2023** approved as a correct record.
- 24.05 Minutes of the Extraordinary meeting held on Wednesday 10<sup>th</sup> January 2024 approved as a correct record.
- **24.06** Confidential/Urgent items and order of the proceedings The Council resolved that Item 24.16 be determined as confidential.
- **24.07 Community Speed Watch** The Council discussed the issue of speeding in Middleham and identified the following locations to be monitored by the Community Speed Watch Scheme:
  - The top of the Market Place down to Kirkgate
  - Leyburn road from Antiques Shop/Middleham Garage going towards Leyburn.

**Action** – Clerk to report the sites of concern to the Police.

# 24.08 Reports

- a) Councillors to report any meetings attended and actions undertaken. Cllrs Watson, Byford, Palethorpe and Mashford attended a site meeting with Highways and G Hoerty Associates where concerns over the new development were discussed.
- b) Matters of local interest and concern as reported to Councillors or on Residents Facebook page. Cllr Skelton reported some solar equipment that had been stolen from the Low Moor. The incident has been reported to the Police. Cllr Palethorpe was approached by a resident in relation to concerns over parking at the top of the green on Park Lane and whether it



- was possible to add additional parking spaces, Councillors noted that this had been discussed previously but this wasn't an option due to costs.
- c) Police and Fire Matters PCSO Watson updated the Council on vehicle related issues in the area, there are still ongoing issues with quad bikes. Concern was also expressed about the worn road markings at the junction on Coverham Lane with the A6108.
  - **Action** Clerk to report the worn road markings to Highways.
- d) Events in Middleham Middleham Open Day Friday 29th March 2024.
- e) **Clerks Report** The Clerk attended a Highways Parish Workshop where discussions were held around how to report highways issues in a Councils parish and how Highways prioritise issues raised about the highway.

## 24.09 Land Management

- a) Litter Picking/ Weed Killing The Council discussed the options for cleaning up around Middleham, specifically litter picking and the problem with weeds and resolved to hold a Community Litter Picking event on Sunday 24<sup>th</sup> March 2024 at 10am to start from the Key Centre Middleham.
- b) Middleham Open Day Councillors discussed the request received from Racing Welfare to hold the annual Middleham Open Day and place public conveniences on Council land on Good Friday, Friday 29<sup>th</sup> March 2024 and resolved to approve the request.
- c) Ash Tree on St Alkeldas Councillors discussed the request, for works to be completed to branches of an Ash tree on Council land that overhangs a property, along with the arborists report following a visit in March 2023 and resolved to closely monitor the situation and take any appropriate action following the next survey due in March 2024.

- b) Ref: ZD23/00665/OUT Proposal: Outline Planning Permission with all Matters Reserved for Proposed Residential Development (up to 55 Dwellings) Location: Land at St Alkeldas Road, Middleham, North Yorkshire.
  - The Council makes the following observations and request that each of these matters should be made the subject of conditions if approval is granted to this application.

#### Access/Exit route for Houses on the Busks

Concerns were raised about the safe access and exit route for the 8 semi-detached houses on the Busks, Leyburn Road. The Council feel that more consideration is needed in relation to the provision of a safe access and exit route for these properties where it feeds into the development entrance and thence onto or in from Leyburn Road, including suitable road markings and measures to manage the potential conflict between vehicles turning out of the Busks access and those turning into the development access road. A detailed design including profiles should be produced to be consulted and agreed with Middleham Council, resident's and the Highway Authority. The land take from the Common Land to be minimised to the least required by the Highway Authority.

Councillors would like the area in front of these houses to retain its full width (for both access and parking purposes) for the affected properties and that the area be tarmacked (at the Developers expense) provided this is acceptable to the Open Spaces Society.

The Council reiterates its proposal that, in addition to monetary exchange for the area of Common Land required for the entrance, an area of land at least 6 metres wide across the entire southern boundary of the site, including the Public Right of Way footpath, should be gifted to



the community in recompense for the Common Land lost. This area extending through the south east pedestrian access would be contiguous with existing land held beside St Alkeldas.

If the banked area between the houses on the Busks and Leyburn Road is reduced it is important that retaining measures are put in place to ensure the area is secure from subsidence and safe for all users .

#### **Road Layout**

As the Council understands it a third lane was to be implemented arising from the siting of the 60/30 speed limit sign, if the sign was to be moved closer to Leyburn Council would like clarification that a third lane would not be required either way as the junction would be no different to that of St Alkeldas or many others in Middleham?


The Council would be strongly opposed to the introduction of a right turning lane from eastbound traffic on Leyburn Road as suggested by the Local Highways Authority and the additional take of the common land that this would incur. The Council would prefer to see the 30MPH speed limit moved further Northwest beyond the apex of the bend towards Leyburn. The reduction in speed of approaching traffic should obviate the need for a turning lane.

Council notes that no such lane has been considered necessary for the right turn into St Alkeldas, within 300 metres of this site. St Alkeldas is a through route that carries significantly more traffic into The Springs, Park Lane, St Alkeldas and Kingsley Drive and Middleham School and Middleham Key Centre than will be generated by the up to 55 dwellings in the new development. The collision and casualty data indicates that the St Alkeldas junction is working safely.

For safety reasons there should be adequate street lighting introduced at the junction entering the new development. This lighting to be designed to minimise potential glare into the existing houses on the Busks and to be downward lighting that does not cause light pollution into the sky and the adjacent mature trees and bird nesting areas.


Monthly Police Report – 4th Nov 2023 – 5th Jan 2024
