

Minutes of the meeting of Middleham Town Council held in the Garden Room, Middleham Key Centre on Wednesday 28th February 2024 at 6.30p.m.

 - 24.26 Public Representations/Open Forum Concerns were raised by a resident in relation to parking issues at West End Middleham (specifically horseboxes which unload horses to go up on to the Moor and leave their ramps down while they are gone before returning with another load), vehicles parking on the pavement from the school to St Alkeldas and the use of the gallops after 1p.m. Action – Clerk to contact the MTA regarding the parking issues at West End.
 - **24.27** Apologies Apologies of absence received from Cllr Pead-Jowett and County Councillor Karin Sedgwick and reasons given for absence approved.
 - 24.28 Declarations of Interest None other than those already previously disclosed.
 - **24.29** Minutes of the meeting held on Wednesday 31st January 2024 approved as a correct record.

 - Waste food items are still being thrown across the burial ground Action Clerk to gather information on CCTV and signage for March meeting.
 - Concerns in relation to the number of racehorses using Park Lane
 - Concerns around the way vehicles are being driven on Park Lane specifically into the corner at the Chapel.
 - The amount of dog faeces on the footpath from Park Lane to the Church yard.
 - The footpath through the church yard is dangerous when wet.
 - The number of streetlights currently not working.




- The vehicle parked in the Marketplace which has been there for some time.
- Concerns have also been reported about the increase in people using Back Street as a cut-through.
- A query was raised as to what was happening with the re-surfacing of Canaan's Lane. This is currently on hold as all parties affected must agree and there are issues with one property being empty and the other up for sale.

Appendix 2 – Police Report


Monthly Police Report - Jan 5th – Feb 7th 2024

We do not report crimes whereby victims could be identified, for example Domestic Violence or harassment although they are included in the totals below.

Crimes of note; 7th Jan thieves entered the changing room at Cawkhill Park during a Rugby match stealing several mobile phones and purses, transactions were also carried out on the stolen bankcards. Overnight 26th Jan, 2 Quad bikes were stolen from the Carpley Green area, one fitted with a tracker was later recovered in the Bradford area. Overnight 4th Feb, Burglary at Yorebridge House an amount of cash was taken. Overnight 5th Feb, a Quad bike and a generator were stolen from the Wensley area.
