

Minutes of the meeting of Middleham Town Council held in the Garden Room, Middleham Key Centre on Wednesday 27th March 2024 at 6.30pm.

24.81 Public Representations/Open Forum – Cllr Sedgwick updated the Council on a transport survey which was due to be delivered to residents and asked if these could please be filled and returned. Councillors were informed that the HSBC building in Leyburn had now also been sold and there was a planned open day on the 12th April 2024.

- **24.84** Minutes of the meeting held on Wednesday 28th February 2024 were approved as a correct record.

24.87 Committees

- a. Racing Welfare Committee Councillors discussed a representative to sit on the Racing Welfare Committee and resolved to nominate Cllrs Mashford and Watson to attend these meetings.
- b. North Yorkshire Community Partnerships Steering Group The Council discussed a representative to attend the North Yorkshire Council Community Partnerships Steering Group meetings and resolved to nominate Cllr Palethorpe and in his absence Cllr Skelton.

24.88 Reports

 a. Councillors to report any meetings attended and actions undertaken – None.



b. Matters of local interest and concern as reported to Councillors or on Residents Facebook page. – Cllr Watson had been approached by residents in relation to the planning application at St Alkeldas it was confirmed that the outline planning application had still not been approved yet. Cllrs Palethorpe and Pead-Jowett informed the Council that a sink hole had appeared in the play park, this had been filled but is now re-appearing.

Action – Cllr Palethorpe agreed to have another look.

Action – Clerk to contact the drain company to ask them to have a look whilst in Middleham.

The Council was also informed of parking issues outside a cottage on East Witton Road which is causing issues again and a rockery that has also been built in front of one of the houses on East Witton Road.

Cllr Watson reported a leaking water pipe outside the antiques shop in the Market Place.

Action – Clerk to contact Yorkshire Water.

- c. **Police and Fire Matters** PSCO Watson updated the Council on a current national operation that took place in Middleham with a drug dog in March to deter the spiking of drinks. PCSO Watson also confirmed that the parking issues on Park Lane had improved.

- e. **Clerks report** Councillors have been invited to attend a public meeting sponsored by The Association of Rural Communities on Tuesday 30th April 2024 at 7.30pm in Leyburn Methodist Church Hall. Cllr Palethorpe confirmed he would be interested in attending.

- b. Complaints Policy The Council reviewed the complaints policy and resolved to adopt this pending an addition confirming the process to follow in the escalation of complaints if the complainant is not happy with the response received.

- f) Approval of invoices awaiting payment approved.


24.93 Middleham Key Centre
