Appendix 3 - Police & Fire Matters

Monthly Police Report - May 7th - June 7th

We do not report crimes whereby victims could be identified, for example, Domestic Violence or Harassment although these are include in the totals below.

Leyburn Police Station covers the areas of Arkengarthdale, Swaledale from Hudswell up to the county border. Wensleydale from the Hambleton to Cumbria borders, Coverdale and Bishopdale,

Crimes of note; between 26^{th} - 27^{th} May 2 x electric bicycles were stolen from bike racks on a vehicle in the Low Row area. Overnight 2^{nd} - 3^{rd} June a Burglary took place at Wensley Rugby Club and a large amount of cash was stolen. Between 4^{th} - 6^{th} June 19 ewes and 31 lambs were reported as stolen from the Gayle area.
